No Ordinary Barn

The excitement surrounding the initial opening of the Nicholas Stoltzfus House will soon be reborn. The Nicholas Stoltzfus House Preservation Committee is pleased to announce that plans are underway to build a barn adjacent to the house.

The mission statement for the Preservation Committee includes the following objective: The Stoltzfus House and other artifacts of the Stoltzfus family are being restored and preserved as an example of the humble attitude of obedience, forgiveness and their willingness to share and help others in need. As a fulfillment of that portion of the mission statement, the Preservation Committee purposed to build a barn.

The barn will be re-constructed in location and architecture to replace the barn structure that would have been on the property with the home. It will serve as a museum and public rest area for visitors of



the Nicholas Stoltzfus property. The barn will also provide living quarters for the property's caretakers. To best serve its purpose, the barn will have to be a historically accurate structure as well as provide the necessary climate

Way to Visit the Stoltzfus House!

Each year Mose Riehl has arranged a wagon train for his family to an interesting site. Well, Mose Smucker suggested the NSH, so they together took the 22 miles from Churchtown to Wyomissing Monday, Aug 20.

Christian Stoltzfus made similar trips in his lifetime (ca1770 to 1810). But then the roads were crude. Yes, he did not have to contend with big



trucks and fast cars. After living in Cumru Township (now Wyomissing) he moved beyond New Holland in the Mill Creek area, without the help of a jeep escort like Carl Good.

Will these children reflect on this as they remember their wagon ride



to the Nicholas Stoltzfus House? Will they be able to connect their past to their future? What will the Stoltzfus House mean to them? Will it be a place to which they would bring their children?



About 20 horses, 10 wagons, and 60 people came to spend three days, intending to put up tents and camp. But it rained, and rained, continuously so as not to allow this. Many slept in the House. Mose said they could not have chosen worse days for this.

Some facilities were available, two porta-johns were rented for the occasion. The fireplace provided some warmth. The Brunks living in the house trailer next were most gracious. Yet there must have been a

Heritage of the Gospel Among the Stoltzfus Family

When the first Stoltzfus deed was obtained in Cumru Township, Nicholas and Christian both signed the agreement. Most of what we know of Nicholas is found in the Germany side documents requesting marriage to the Anabaptist woman. This deprived Nicholas of civil rights, thus he sought permission to emigrate. His newfound faith meant that much to him.

Christian also left evidence of a devoted life. We have his Bible. We know he served as bishop in the Amish brotherhood. His family carried on the Gospel way. Even today we see varied illustrations of such devotion in the work and life of so many descendants. We hope to depict illustrations, not to praise anyone, but to value the faith of Christian and Nicholas thus to honor our God who has been so gracious to us. We praise God that He would have mercy upon us.

Calvin pushed the idea of collecting Stoltzfus Influence stories. We have a room which could be dedicated for this purpose. Marie E. Cutman, (her book: We sat where they sat: Ada and Ida Stoltzfus: thirty-seven and one-half years in the ancient city of Hebron. Morgantown, PA: Masthof, 1996) agreed to prepare a tribute to be placed in the House.

This follows the urging of Merle Stoltzfus (Ammon & Barbara) that we present a Gospel emphasis through the preservation. We have the books—Bible, Martyrs' Mirror, Ausbund—that nurtured the faith in these ancestors. The next step is to portray how this has formed lives among descendants. Ada and Ida could be the model for this as they persisted in God's work to keep the Palestine orphanage open. Many other similar effects from the lives of descendants may emerge.

control to preserve its artifacts. The end result should be a practical and beautiful structure to compliment the Nicholas Stoltzfus House and provide a large part of the facilities necessary to fulfill our mission.

Back on May 12 at the auction, the Preservation Committee introduced their plans to pursue the barn's construction. The completed historically correct design and plans express a practically stunning structure. Since May, the committee has appointed an advancement committee to invite people to invest in this worthy enterprise and also secured a general contractor and builder to fulfill this task. The fundraising is just beginning with the hopes of breaking ground in early 2008.

The completion of the barn will join the House in fulfilling the mission of the Preservation Committee. The Committee's vision to restore

and preserve the Stoltzfus heritage for the glory of God will be literally exemplified through the barn. The museum section of the barn specifically will bring to life the history of Gospel of Christ throughout the Stoltzfus line.

The heritage is one where living and sharing the Gospel has been a priority. Artifacts and plagues will relay inspiring stories of the past, where *God's* work was being done in our family. Hopefully, the stories of yesteryear will be an inspiration to both family and visitors today.

The Preservation Committee looks forward to its second grand opening. The House was a milestone in itself, but we can look forward to the barn's significant part of fulfilling the overall mission of the Preservation Committee.
